CONSTRUCTION ACTIVITIES UPDATE

Construction Activity No. 1:

NW 25th Street from NW 39th Avenue to SR-953/NW 42nd Avenue (LeJeune Road)

Commencing Monday, June 7, 2004 through Thursday, June 10, 2004, there will be intermittent lane closures on NW 25th Street between NW 39th Avenue to SR-953/NW 42nd Avenue (LeJeune Road). **Lane Closures will occur daily from 9:00 AM to 3:30 PM.** Two-way traffic will be maintained using flag persons to divert traffic around the work zone. Commuters should follow construction signs. The lane closures are due to utility work for the Miami Intermodal Center Rental Car Facility. Work is being performed by Turner Construction (Central Florida Equipment).

Construction Activity No. 2:

Miami-Dade Expressway Authority (MDX) Project: Construction of an Additional Westbound Lane from SR-112 to Okeechobee Road Off-ramp

DATES: June 6 to June 13, 2004 (Prepared May 26, 2004)

MAINLINE: As part of the improvements, there will be intermittent lane closures, one at a time, on westbound SR 112 between NW 32nd Avenue and Okeechobee Road from Monday, June 7 to Friday, June 11, 2004. These closures will be during the non-peak hours of 9:00 a.m. and 3:00 p.m. During the night, up to two lanes will be closed from Monday, June 7 to Friday, June 11, 2004. One lane will be closed from 9:00 p.m. to 5:30 a.m. and the second lane will be closed from 11:00 p.m. to 5:30 a.m.

RAMP CLOSURE: Also, on westbound SR 112, the new exit ramp to Okeechobee Road will be closed from 9:00 p.m. to 5:30 a.m. from Monday, June 7 to Friday, June 11, 2004. Variable message signs (VMS) will be posted.
