CONSTRUCTION ACTIVITY #1:

Temporary Nighttime Lane Closure at the Southwest corner of LeJeune Road (SR-953/NW 42nd Avenue) Southbound and NW 11th Street:

On Monday, May 15th, 2006 from 10:00 P.M. to 5:30 A.M.: As part of the MIC's LeJeune Road Corridor Projects - Package 2, **the outside lane at the southwest corner of LeJeune Road (SR-953/NW 42nd Avenue) southbound and NW 11th Street will be temporarily closed.** Access to businesses on that corner will be maintained at all times. This closure is required to prepare the foundation for a traffic signal. Work is being done by Kiewit Southern Co. (formerly Gilbert Southern Corp.) for the Florida Department of Transportation.
