CONSTRUCTION ACTIVITY #1:

NW 21ST Street from approximately 500' West of NW 37th Avenue to just West of NW 39th Avenue:

Wednesday, April 2, 2008 from 8:00 P.M. to 11:00 P.M. and again Thursday, April 3, 2008 through Friday April 4, 2008 from 9:00 A.M. to 3:30 P.M. (Daily): The outside westbound lane on NW 21st Street from approximately 500' West of NW 37th Avenue to just West of NW 39th Avenue will be temporarily closed while crews install the barrier wall and maintenance of traffic devices in preparation of Phase I construction for the MIC Roadway Improvement Projects. One lane will remain open at all times. Work will be performed by MCM General Contractors on behalf of the Florida Department of Transportation.

CONSTRUCTION ACTIVITY #2:

Full Closure of Westbound Lane on NW 28th Street from NW 39th Avenue to just East of NW 42nd Avenue (LeJeune Road):

Monday, April 7, 2008 through Monday, June 30, 2008: Crews will begin installing the barrier wall and maintenance of traffic devices in preparation of Phase I construction for the MIC Roadway Improvement Projects on **Monday, April 7, 2008 at 8:00 P.M.** Once the installation of the barrier wall is complete, the westbound lane on NW 28th Street from NW 39th Avenue to just East of LeJeune Road will be completely closed during the period of **April 7, 2008 through June 30, 2008. Business Access will be maintained at all times. Commuters should follow the posted detour on the attached Phase I Map.** This closure is necessary to begin the installation of the new drainage and roadwork along NW 28th Street. Work will be performed by MCM General Contractors on behalf of the Florida Department of Transportation.

*Nearby business interests and residents affected by construction of the Miami Intermodal Center and other nearby construction projects will receive periodic Maintenance of Traffic (MOT) bulletins giving road closure information and suggesting alternate routes. This information is being provided by the **One Stop Shop Traffic Information Program** sponsored by the Florida Department of Transportation and its partnering agencies Miami-Dade County, Miami-Dade Aviation Department, Miami International Airport, Miami-Dade Expressway Authority, Tri-Rail, Miami-Dade Transit, Miami-Dade Office of Public Transportation Management, Cities of Miami, Hialeah, Miami Springs and Virginia Gardens, and local Utilities. Thank you for your patience while we work to improve the roadways in this area. 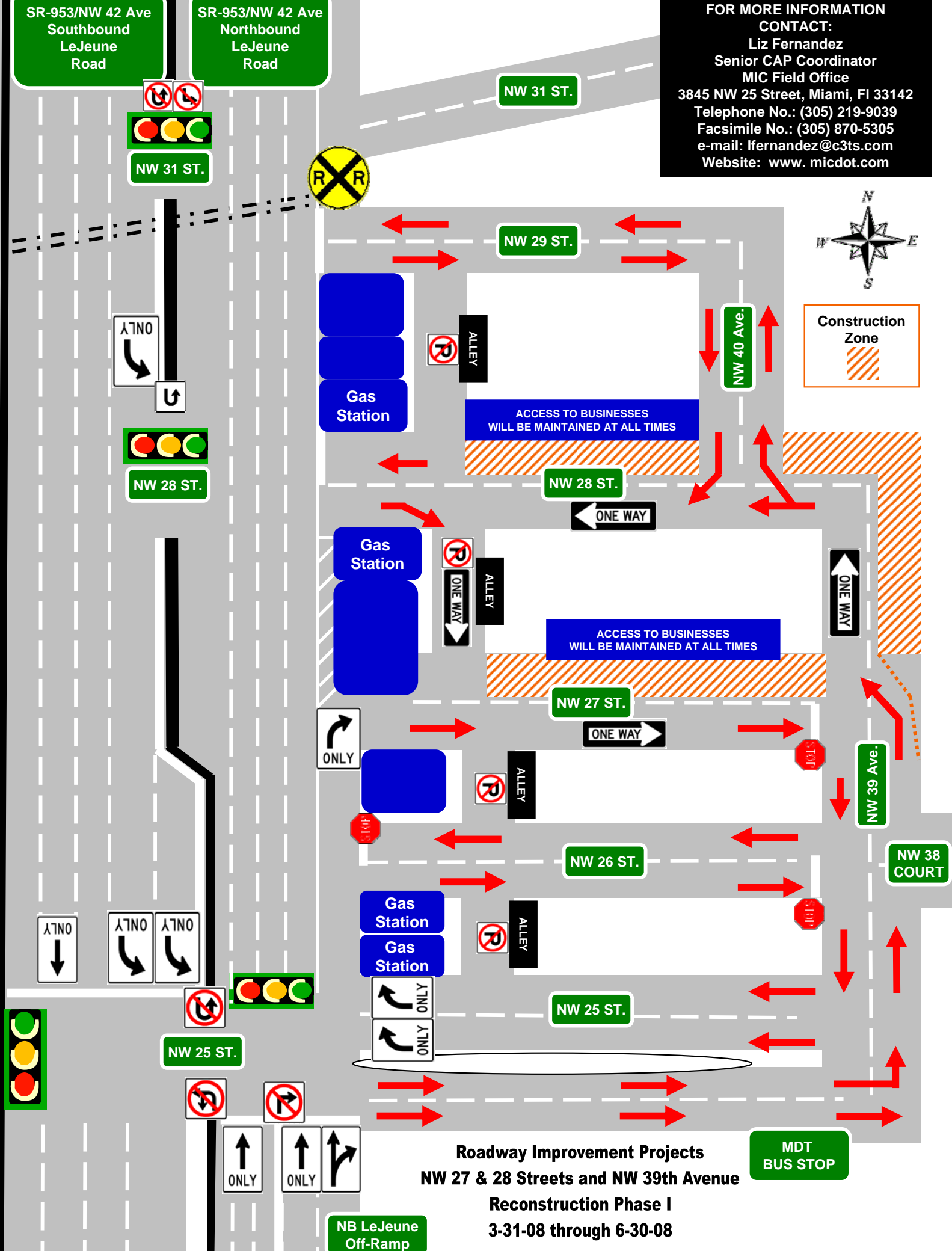
SR-953/NW 42 Ave
